- The application is in compliance with the Land Use Bylaw, Municipal Development Plan, Municipal Government Act, and Subdivision and Development Regulation.
- The developer must provide detailed plans to describe how the storm water will run.
- The applicant owner must allow for an easement along the east side of the proposed 4.75 acres for future water and sewer services.

f) Sewer Cost Reimbursement

Council discussed the Gould's request for sewer cost reimbursement, cameraing the sewer line and purchasing the extension for the power snake. The extension for the power snake has been ordered and arrangements for cameraing this sewer line along with others are being made.

Letters will be issued to property owners notifying them that their driveways must come off of 55th Avenue as the undeveloped road easements of 47th and 48th Streets, North of 55th Avenue, will not be developed or maintained by the Village until the properties to the North are developed.

h) Sewer/water

F. Rapati reported on the sewer plug in the main located between the manholes in Dalmacs yard and the one located on 770 West of Dalmac.

8. Committee Reports

a) Communities in Bloom

F. Rapati reported on their June meeting in regards to the plant and tea sale, on their tours, on the entrance way project, Village of Warburg sign, and the plants.

b) Fire Department

For the month of May the Fire Department had 1 medical call, 1 fire call, mutual aid at Breton and 1 false alarm and their activities consisted of BA practice and use of fill station. For the month of June they had 2 false alarms, 3 medical calls, 1 animal rescue, 1 fire call and 1 water rescue with mutual aid called from Devon, Wabamum & RCMP Water Rescue. June activities consisted of fall training programs planned and standby for Demo Derby with 1 medical incident. There are no practices during July and August, on-call weekends remain the same as well as monthly County maintenance night.

c) Recreation Board

F. Rapati reported that the allocation to the baseball was held and other allocations were paid out.

D. Kohl reported on the integrated transportation regional master plan and on the transit service plan.

e) FCSS
