Mayor van Assen noted that you either participate fully or not at all. He noted that if we have to pay to sit at the table to support Edmonton, we will not participate, as being a small municipality we cannot afford to.

Mr. Bruce spoke on behalf of the Growth Plan, support smaller communities and he thinks they can get us some money for the 39/20. He also spoke on the Green Trip monies and that there are opportunities.

Deputy Mayor Rapati noted that we cannot afford to contribute to the city projects.
